- 7. <u>Termination</u>. This Agreement may be terminated without cause at no cost to either party upon DAYS advance written notice (30 unless otherwise indicated). Upon termination, Speaker will refund to ASU all prepaid amounts for services not delivered or performed. If either party cancels this Agreement or the Presentation with less than the required notice, other than due to an event of Force Majeure, the other party will have all remedies afforded by law and in equity.
- 8. <u>Authority</u>. If an individual or entity signs below on behalf of Speaker, such signatory represents and warrants that he/she/it has full and current authority to act and contract on behalf of Speaker and obligate Speaker, and that this Agreement is binding upon and enforceable against Speaker and the undersigned (if not Speaker) in accordance with its terms.
- 9. Liability; Insurance. Speaker, at its expense, will procure and maintain, for the duration of the Event, a policy of commercial general liability insurance in an amount of not less than \$1,000,000, single limit, against claims for bodily injury, death and property damage occurring in connection with the Event and the Presentation. This insurance must name the Arizona Board of Regents, Arizona State University, and the State of Arizona as additional insureds. If requested by ASU, speaker must provide ASU with a certificate evidencing this insurance coverage no later than 10 days prior to the presentation. The insurance requirements of this provision will not apply to a Speaker where: i) the Presentation is primarily academic in nature; ii) the total compensation under Section 3 above (including any honorarium) is \$1,000.00 or less; iii) Speaker's primarily occupation is not acting as a speaker/artist/performer; and iv) a significant portion of Speaker's income is not derived from acting as a speaker/artist/performer.
